Textual Information()	We hereby state that Pentokey Organy (India) Limited (the Company) was originally managed by Shri Rajendra V. Shah, the then Promoter, Chairman & Managing Director of the Company and his family members. The net worth of the Company got fully eroded and was registered as a Sick Industrial Company with Board for Industrial and Financial Reconstruction (hereinafter called BIFR) under the provisions of Sick Industrial companies (Special Provisions) Act, 1985. In February, 2007 BIFR directed the Operating Agency to submit Draft Rehabilitation Scheme (DRS). On the basis of DRS, BIFR had sanctioned a scheme for reviving the Company. As per the Sanctioned scheme the Company was directed to bring Rs. 302.56 Lakhs in the form of Equity from Promoter/ Associates and Strategic Investor. Sakarwadi Trading Co. Private Limited, Somaiya Agencies Private Limited, Jasmine Trading Company Private Limited and Godavari Biorefineries Limited had infused the above mentioned amount as Strategic investor and became the Promoters of the Company. Shri R. V. Shah transferred his shareholding and resigned from the Board. However some of the family members, relatives and associates of Mr. Shah are still holding shares in physical format. The shareholding in physical format is 29,417 (0.44%) which is very miniscule. The Company has approached these persons multiple times to dematerialize their shares by issuing letters. However despite of sending reminders we havent received any response from them.
